

**RESOLUTION 638 OF THE BOROUGH COUNCIL OF MONT ALTO,  
FRANKLIN COUNTY, PENNSYLVANIA, ADOPTING AN AMENDED FEE  
SCHEDULE FOR USE OF THE RECREATION AREA FACILITIES PURSUANT  
TO ORDINANCE NO. 446 OF THE BOROUGH OF MONT ALTO**

**WHEREAS**, Borough Ordinance 446 established a schedule of fees and policies for use of specified Mont Alto recreation facilities; and

**WHEREAS**, the Borough of Mont Alto desires to change certain fees related to the use of specified Mont Alto recreation facilities;

That the attached schedule of fees and policies is adopted in connection with the use of specified facilities at the Mont Alto Recreation Area.



## SCHEDULE OF FEES AND POLICIES - 2016

The Borough of Mont Alto does hereby establish the following schedule of fees for the use of the specified facilities located at the Mont Alto Recreation Area.

I. Fees for Large Pavilion:

- A. Daily rate from 6:00 a.m. through 4:00 p.m. for residents of the Borough of Mont Alto \$30.00 and non-residents \$45.00;
- B. Evening rate from 4:00 p.m. through dark for residents of the Borough of Mont Alto \$20.00 and non-residents \$30.00;
- C. All day rate from 6:00 a.m. through dark for residents of the Borough of Mont Alto \$40.00 and non-residents \$60.00.

II. Fees for Small Pavilion:

- A. Daily rate from 6:00 a.m. through 4:00 p.m. for residents of the Borough of Mont Alto \$20.00 and non-residents \$25.00;
- B. Evening rate from 4:00 p.m. through dark for residents of the Borough of Mont Alto \$15.00 and non-residents \$20.00;
- C. All day rate from 6:00 a.m. through dark for residents of the Borough of Mont Alto \$25.00 and non-residents \$30.00.

III. Payment of Fees and Refund Policy

1. All fees for the use of the either of the Pavilions are due and payable at the time of application for use thereof.

2. Charitable organizations or non-profit groups, having a principal place of business within the Borough are permitted to have one fund raising event per year at either pavilion, without payment of the fee.

3. In the event of cancellation of a reservation of either pavilion, the Borough should be notified immediately. Those applicants providing notice of cancellation at least 30 days prior to the scheduled event shall be entitled to a full refund of the fee paid for the pavilion. If notice of cancellation is received by the Borough within the 30 day period preceding the scheduled event, applicant will receive a refund of one-half (1/2) of the fee paid.

III. Restroom Access – Should any resident or non-resident of the Borough, in conjunction with their use of the either of the pavilions, desire restroom access, they shall

be required to notify the Borough at the time of application for use of the pavilion, and post a KEY DEPOSIT of \$10.00. Said key shall be picked up from the Borough no earlier than two days before the event. Upon completion of the event the key must be returned to the Borough Office of if after hours, the depository on the front door of the Borough Office prior to 8:30 a.m. the first business day following the event. If said key is returned the key deposit will be refunded.

#### **IV. Rules regarding use of Pavilions**

A. Picnic tables, garbage cans and other items may be moved and /or rearranged however, same must be returned to their original positions at the end of the event.

B. No staples, tacks, pins or other pointed devises shall be used on any table, bench or any structural member of the pavilions.

C. The pavilions shall be left in a clean condition, with all trash bagged and placed in proper receptacles.

D. Persons using the pavilions hereunder shall conduct themselves in a manner compliant with the existing rules of conduct for the recreation area.



ORDINANCE NO. 446

**AN ORDINANCE AMENDING ORDINANCE NO. 398 CONCERNING THE RULES AND REGULATIONS FOR THE UTILIZATION OF RECREATION FACILITIES WITHIN THE BOROUGH OF MONT ALTO AND IMPOSING FINES, PENALTIES AND FORFEITURES FOR VIOLATION THEREOF.**

BE IT ORDAINED AND ENACTED AND IT IS HEREBY ORDAINED AND ENACTED BY THE TOWN COUNCIL OF THE BOROUGH OF MONT ALTO, FRANKLIN COUNTY, PENNSYLVANIA:

SECTION 1: Section 4 of Ordinance No. 398 is hereby amended to read as follows:

USE OF FACILITIES AND FEES RELATED THERETO: The Borough shall maintain and post schedules for the use of certain facilities and/or buildings at recreation areas, primarily picnic areas and baseball fields, as well as fee schedules for same, a copy of which is appended hereto, made part hereof and marked Exhibit A. Said fees and the policies concerning collection, exemption or refund of said fees may be from time to time amended by resolution of the Borough Council.

Individuals, groups or organizations scheduling activities using one or more of the scheduled facilities shall have exclusive use of said scheduled facility for the hours indicated on the schedule maintained by the Borough. When there are no scheduled activities for a certain facility or recreational area, it is available for use by the public, during the hours of operation.

SECTION 2: The remaining provisions of Ordinance No. 398 of the Borough of Mont Alto, Franklin County, Pennsylvania, not amended hereby, shall remain in full force and effect.

SECTION 3: Upon enactment by the Borough Council, this amendment to Ordinance No. 398 shall become effective immediately upon adoption.



## **SCHEDULE OF FEES AND POLICIES**

The Borough of Mont Alto does hereby establish the following schedule of fees for the use of the specified facilities located at the Mont Alto Recreation Area.

**I. Fees for Large Pavilion:**

- A. Daily rate from 6:00 a.m. through 4:00 p.m. for residents of the Borough of Mont Alto \$25.00 and non-residents \$35.00;
- B. Evening rate from 4:00 p.m. through dark for residents of the Borough of Mont Alto \$15.00 and non-residents \$20.00;
- C. All day rate from 6:00 a.m. through dark for residents of the Borough of Mont Alto \$35.00 and non-residents \$50.00.

**II. Fees for Small Pavilion:**

- A. Daily rate from 6:00 a.m. through 4:00 p.m. for residents of the Borough of Mont Alto \$15.00 and non-residents \$15.00;
- B. Evening rate from 4:00 p.m. through dark for residents of the Borough of Mont Alto \$10.00 and non-residents \$10.00;
- C. All day rate from 6:00 a.m. through dark for residents of the Borough of Mont Alto \$20.00 and non-residents \$20.00.

**III. Payment of Fees and Refund Policy**

1. All fees for the use of either of the Pavilions are due and payable at the time of application for use thereof.

2. Charitable organizations or non-profit groups, having a principal place of business within the Borough are permitted to have one fund raising event per year at either pavilion, without payment of the fee.

3. In the event of cancellation of a reservation of either pavilion, the Borough should be notified immediately. Those applicants providing notice of cancellation at least 30 days prior to the scheduled event shall be entitled to a full refund of the fee paid for the pavilion. If notice of cancellation is received by the Borough within the 30 day period preceding the scheduled event, applicant will receive a refund of one-half (1/2) of the fee paid.

III. Restroom Access – Should any resident or non-resident of the Borough, in conjunction with their use of either of the pavilions, desire restroom access, they shall be required to notify the Borough at the time of application for use of the pavilion, and post a KEY DEPOSIT of \$ 2.00. Said key shall be picked up from the Borough no earlier than two days before the event. Upon completion of the event the key must be returned to the Borough Office or if after hours, the depository on the front door of the Borough Office prior to 8:30 a.m. the first business day following the event. If said key is returned the key deposit will be refunded.

IV. Rules regarding use of Pavilions

A. Picnic tables, garbage cans and other items may be moved and /or rearranged however, same must be returned to their original positions at the end of the event.

B. No staples, tacks, pins or other pointed devices shall be used on any table, bench or any structural member of the pavilions.

C. The pavilions shall be left in a clean condition, with all trash bagged and placed in proper receptacles.

ORDINANCE NO 398

AN ORDINANCE OF THE BOROUGH OF MONT ALTO, FRANKLIN COUNTY, PENNSYLVANIA, PROVIDING THE RULES AND REGULATIONS FOR THE UTILIZATION OF RECREATION FACILITIES WITHIN THE BOROUGH OF MONT ALTO AND IMPOSING FINES, PENALTIES AND FORFEITURES FOR VIOLATION THEREOF

BE IT ORDAINED AND ENACTED AND IT IS HEREBY ORDAINED AND ENACTED BY THE TOWN COUNCIL OF THE BOROUGH OF MONT ALTO, FRANKLIN COUNTY, PENNSYLVANIA:

SECTION 1: PURPOSE: The Borough Council of the Borough of Mont Alto has created recreational facilities for the benefit, pleasure and convenience of the public. Details, rules and regulations are required for the purpose of providing for the safety and general welfare of those using said recreational facilities.

SECTION 2: DEFINITIONS:

- A. "Recreation Area" shall be construed to include all land and improvements thereon under the control of the Borough of Mont Alto, which are made available by the Borough of Mont Alto to the public for recreational activities.
- B. "Person" shall refer to individual persons, groups, or organizations who shall utilize the recreational areas of the Borough of Mont Alto.
- C. "Recreation Board" is an appointed advisory board created by the Borough Council to provide input as to matters relating to recreational activities and the use, maintenance and improvement of recreation areas within the Borough of Mont Alto.

SECTION 3: HOURS OF OPERATION: Recreation areas shall be open each day of the year between dawn and dusk.

SECTION 4: USE OF FACILITIES: The Borough shall maintain and post schedules for the use of certain facilities and/or buildings at recreation areas, primarily picnic areas and baseball fields. Individuals, groups or organizations scheduling activities using one or more of the scheduled facilities shall have exclusive use of said scheduled facility for the hours indicated on the schedule maintained by the Borough. When there are no scheduled activities for a certain facility or recreational area, it is available for use by the public, during the hours of operation.

SECTION 5: PERSONAL CONDUCT AT RECREATION AREAS:

- A. All individuals, groups, and/or organizations shall be respectful of others using the recreation areas and shall refrain from using indecent language or engaging in immoral, lewd, lascivious, threatening, assaultive, or boisterous conduct or actions.
- B. Hunting, shooting, trapping or the carrying of firearms, air-rifles, bows and arrows, slings, slingshots, fireworks, or any other explosive device or weapon is prohibited.
- C. Chipping, putting, hitting or driving golf balls is prohibited.

D. Consumption or possession of alcoholic beverages and/or controlled substances is prohibited. Further persons actually or apparently under the influence of alcohol or controlled substances will be prohibited from entering onto recreation areas, or, if present, will be removed from said areas.

E. Pets must be leashed and in the immediate presence, custody and control of the owner and/or guardian at all times. Pet owners and/or guardians bringing pets onto recreation areas shall be responsible for the removal and disposal of the offal of their pets. Horses, exotic animals and livestock are not permitted in recreation areas.

F. All trash, garbage and litter shall be deposited in the refuse cans provided by the Borough and located at various locations throughout the recreation areas. Scattering, dropping, dumping or leaving any trash, litter or substance of any kind or polluting or dumping any matter on any portion of the recreation areas by any person, group or organization is prohibited.

G. Damaging, destroying, defacing, adding to or removing from the recreation areas or any facilities located thereon, including but not limited to equipment, buildings, pavilions, plants, plantings, fencing, sidewalks or parking areas, is prohibited.

H. Intentionally breaking, cutting down, removing or in any other manner injury or defacing any ornament, tree, plants, shrub, Fern, flower (except violets, buttercups, daisies, dandelions), flower beds, turf, or any of the buildings, fences, equipment or other construction within the recreation area, is prohibited.

I. Removing, disturbing, interfering with or taking any of the blossoms growing in the recreation area is prohibited.

J. Use or misuse of equipment within the recreation area with the intent to damage or destroy same is prohibited.

K. Removing, defacing, or destroying, any signs, notices, rules or regulations posted or in any manner of affixed within the recreation area.

L. Excavation or digging in any area of the recreation area with the exception of sandboxes is prohibited.

M. Disturbing bird nests or eggs in any part of the recreation area is prohibited.

N. Erecting or building any temporary or permanent structure including but not limited to tree houses, platforms, goal posts, fences, without the express written authorization of the Borough Council is prohibited.

O. Modifying, adapting, changing, added to or deleting from any present structure or facility without the express written authorization of Borough Council is prohibited.

P. No person, group or organization shall enter or leave the recreation area except by those access points established by Borough Council.

Q. No person shall enter a toilet designated for the sole use of the opposite sex.

R. No person, group, organization shall willfully damage and/or trespass upon property adjacent to the recreation areas.

#### SECTION 6: Vehicular Regulations:

A. Operating or parking any vehicle outside of a designated parking area or designated access way while at or on a recreation area or in an unauthorized, unlawful, reckless or negligent manner, or in such a manner as to be a nuisance or threat to others at or on the recreation area is prohibited.

1. This shall not apply to vehicles belonging to the Borough, fire departments, ambulance services, or police departments or vehicles used by physicians responding to emergency calls at the recreation area(s). Said vehicles shall be operated in a safe and reasonable manner given the circumstances surrounding their presence at the recreation area.

2. Storage, washing, repairing and/or servicing vehicles at or on the recreation areas is prohibited.

3. The use of motorized recreational vehicles, including but not limited to four-wheelers, all terrain vehicles, golf carts, mopeds, motorized scooters, mini-bikes, dirt bikes, unlicensed and/or unregistered motorcycles, within the recreation areas is prohibited. This prohibition shall not apply to motorized wheel chairs, motorized cart, or similar personal transportation used by a handicapped individual to move about the recreation area.

4. The use of bicycles in recreation areas outside of designated parking areas or designated access ways is prohibited.

#### SECTION 7: Group, Club and Organizational Users

A. No gathering or meeting of any kind shall be permitted without the express written consent of the borough Council.

B. No person shall have priority over any person for the use of unscheduled facilities. Reservations of group use facilities and requests for special equipment shall be processed through borough Council.

C. A complete copy of the rules and regulations shall be furnished to each group club or organization scheduling activities at a recreation area.

#### SECTION 8: Erection of Temporary Facilities

A. All temporary structures authorized by the borough Council shall be kept in good repair and condition.

#### SECTION 9: ENFORCEMENT

The mayor shall enforce this ordinance. The section should not be construed to limit enforcement of the regulation set forth by any other authorized law-enforcement agency.

SECTION 10: PENALTIES

A. Any person or persons who shall violate any provision of this ordinance shall, upon conviction thereof, be sentenced to pay a fine of not more than \$300.00 together with the costs of prosecution, and, in default of payment of such fine and costs, to undergo imprisonment in the Franklin County jail for a period of not more than 10 days. All prosecutions shall be brought in the name of the Borough of Mont Alto. All fines shall be paid to the Borough of Mont Alto.

B. A person or persons who violate any of the foregoing rules and regulations to the injury of borough property or to the person or property of any other person shall be liable for such injury in addition to the fines and penalties set forth in this section. This section shall not be construed to limit such liability in any manner.

SECTION 11: SEVERABILITY

The provisions of this Ordinance are severable. If any sentence, clause or section of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such decisions shall not affect the remaining portions of this Ordinance which shall remain in full force and effect and for this purpose the provisions of this ordinance are hereby declared to be severable.


SECTION 12: EFFECTIVE DATE


This Ordinance shall become effective immediately upon enactment and will supersede any contrary ordinance or portion thereof.
