Understanding Your Bill

Customer Charge

 A Monthly fixed charge that reimburses Mont Alto for the cost of maintaining customer's service regardless of how much energy is used. These costs include reading the meter, billing, maintenance and various administrative costs.

Billing Period

 The time period during which a customer received service that is reflected in the bill. Typically, this is approximately 30-days.

Estimated Bill

In the event that Mont Alto cannon read a customer's utility meter due to circumstances such as severe
weather, emergencies or a damaged meter; Mont Alto uses a customer's past meter readings to
estimate electricity, water or sewer usage for billing until the meter can be read.

• Exclusive Electric Service Supplier

The Borough of Mont Alto is the exclusive electric service supplier under Pennsylvania Code(s) and Title
 52, Chapter 54 "Electricity Generation Customer Choice."

Kilowatt (kW)/Demand

 A unit of peak electricity usage for which certain classes of customers are charged and is measured by Mont Alto over a 15-minute period. It measures the maximum amount of electrical energy being used at a given time and is one measure of how large Mont Alto must size its delivery system (lines, transformers, poles, etc.) to serve customers' maximum electrical needs.

Kilowatt-hour (kWh)

A basic unit of energy usage for which customers are charged and measured over a one-hour period. It is
equal to 1,000 watts used for one hour or equivalent to ten 100-watt light bulbs left on for one hour.

Late Payment Charge

• The penalty that is applied to a customer's bill if not paid by the due date. The current late payment penalty by Mont Alto Ordinance is 10%.

Purchased Power Adjustment (PPA)

 A monthly charge per kWh that Mont Alto applies to customer's bills in order to collect any under collection of wholesale power costs.

• State and Local Taxes

 Charges that are required by authorities with jurisdiction to be collected by Mont Alto and then remitted to the appropriate agency.
